#### Shikshak Parv 2022-23

#### Department of School Education and Literacy:

It is proposed to involve all the Schools, Cluster Resource Centres (CRCs), Block Resource Centres (BRCs), DIETs and SCERTs at the State level and all the CBSE affiliated schools including KVs and NVs at the National level for celebrating the Shikshak Parv for 2022-23 in a decentralised manner, with an objective to enhance their ownership for the implementation of the NEP 2020 and empowering them to take collective responsibilities.

In this regard, following activities are suggested:

## **I.** Demonstration followed by Interaction on 'Innovative Pedagogy' for teachers in every School (Time -1 Hr) (On any day between 6<sup>th</sup> – 30<sup>th</sup> September 2022)

#### **Modalities:**

- CRC Resource Person/BRC Resource Person<sup>1</sup>/DIET faculty will conduct a demonstration session with all the teachers in every government school in the respective cluster. The demonstration will be based on teaching a selected topic of a selected subject of any grade in an innovative, joyful and engaging manner.
- 2. Schedule for conducting this demonstration session will be developed at the DIET level involving respective CRC/BRC Coordinator, taking guidance from SCERT.
- 3. All the CRC Resource Persons and BRC Resource Persons will prepare their demonstration plan on innovative pedagogy for a generic session or subject-specific session. This may be planned keeping in view, the needs of school teachers for the orientation on subject-specific pedagogy already identified at the CRC level.
- 4. The Programme Schedule including date, time, and name of the Resource Person for taking session need to be distributed among all concerned CRC/BRC Resource Persona at least three days prior to the programme, so that every RP will get sufficient time for preparation. The teachers from the clusters may also be identified to be a demonstrator in these interactions.
- 5. All the schools will be informed well- in time for the demonstration session ensuring presence of all the teachers for the same.

<sup>&</sup>lt;sup>1</sup> A BRC Resource Person would be a Subject Specific Resource Person or a CwSN Resource Person depending on the subject selected for interaction on Innovative Pedagogy.

- 6. In case of a smaller number of teachers in a school, CRC may decide to hold demonstration session in one school inviting teachers from nearby schools within a range of 1-2 Kilometres.
- 7. For demonstration session, a suitable venue may be identified within the school itself.
- 8. SCERT will take lead in this regard and will inform and provide academic support to all the CRCs and BRCs for this activity.
- 9. In case of **CBSE** affiliated schools including KVS and NVS, a list of teachers/mentors/resource persons need to be prepared for conducting innovative pedagogy / demonstration in every school by the CBSE, KVS and NVS. All the schools may be informed about this activity and the suggested teacher/mentor/resource person. Schools may be asked to conduct this programme at their own level.
- 10. All the schools may also be requested take 4-5 photographs of the Innovative Pedagogy Session for display and upload along with a brief write up of not more than 500 words on the Vidya Amrit Portal ((https://microimp.ndear.gov.in/)

#### Innovative Pedagogy

Pedagogy is at the core of teaching and learning. It is teacher's method of transacting a theme or conducting an activity to make every learner learn in stress-free environment.

On the one hand, some of the pedagogies, such as lecture method, textbookoriented method, chalk and talk method, etc., are in practice for a long time and are being easily adopted by the teachers. These pedagogies have less impact on learning outcomes of children as quoted in many research studies. However, on the other hand there are teachers who use or create pedagogies as per the needs and context of students, which may be termed as Innovative Pedagogies. These are innovative because, these always involve some new components corresponding to the needs of students in different grades and from different socio-economic background. This new component may be a relevant story, or an anecdote told by the teacher or child's experience shared in the classroom or a teaching-learning material, or an engaging activity, e.g., Rather than teaching features of an identified object from the textbook, teacher may ask children having different mother-tongues to tell the name of an identified object in their mother tongue and then motivate them to explain its features one by one.

So, any pedagogy, which engages learners to learn in joyful manner taking care of their learning needs and their socio-economic backgrounds and leads them to achieve learning outcomes may be seen as Innovative Pedagogy. It is integrative, multidisciplinary and inclusive, it leads to holistic development.

#### **II. Senior Students may act as Teachers (On 5th September 2022)**

#### Modalities:

- 1. In every school, some senior students from within the school can be selected by the teachers, to become teachers for the rest of the classes on Teachers' Day. Engagement of classes can cover all the curricular areas including arts, physical education, etc.
- 2. An orientation programme may be conducted by some of the teachers for these senior students on 'how to engage children for learning in a joyful manner'. Every selected student must get at least one period to teach. Effort should be made to provide opportunities to as many students as possible under this.
- 3. The student teachers who receive the best feedback from the children in the classrooms can also be given a certificate of recognition by the school. Feedback may be taken on the student's performance by the regular teachers on the next day.
- 4. In primary schools, class 5 students may be oriented and prepared for engaging with the lower classes under the observation of concerned teachers.
- 5. Teachers may be encouraged to take selfies with the student representatives (as teacher on Teachers Day) and post on Social media with hashtag # humareyteachersabsaybest

## III. Writing of questions/Items based on Learning Outcomes at the school level for an Item bank (from 6<sup>th</sup> September to 18th November 2022)

#### Modalities:

- 1. Every school could try to prepare about three items/questions based on learning outcomes of different subjects, covering different grades.
- 2. Each school can prepare questions/items for Foundational, Preparatory, Middle and Secondary Stage.
- CRC will select three best questions each in different categories i.e., Foundational Stage (for classes 1-2), Preparatory (Classes 3-5), Middle (Classes 6-8) and (Secondary 9-12); and across topics/ subjects. A total of 12 best questions will be submitted to the BRC.
- 4. Each BRC will then select the best four questions from the 12 questions submitted by each CRC and submit these 4 best selected questions to the respective DIET in the district.
- 5. Each DIET will compile all the questions received from all the respective BRCs and send this compiled document to SCERT. SCERT will

compile all the questions received from the respective DIETs and then submit to the Ministry of Education through MyGov.

- 6. The total number of questions estimated to be submitted from across the country is around 28,000.
- 7. The best entries selected at national Level will be given certificates by the NCERT.
- 8. These questions will further be vetted by the NCERT and CBSE for creating a huge ITEM BANK for across the stages.
- Guidelines for writing items for the Item Bank will be prepared by Educational Survey Division, NCERT and shared with SCERTS by 25<sup>th</sup> August 2022.
- 10. Teachers will be able to send in their submissions from the 6th of September 2022 to 26th of September 2022.
- 11. The CRC can review submissions and shortlist them to share with the BRC, between the 26th of September 2022 to the 7th of October 2022.
- 12. The BRC can review the CRC's shortlisted submissions and further shortlist them for the DIET between the 7th of October 2022 to the 14th of October 2022.
- 13. The District Institution of Education and Training (DIET) can review and shortlist the BRP's shortlisted submissions from the 14th of October 2022 to the 21st of October 2022.
- 14. The State Council of Educational Research and Training (SCERT) will be able to review the submissions shortlisted by the DIET between the 21st of October 2022 to the 1st of November 2022.
- 15. The National Council of Educational Research and Training (NCERT) will review and shortlist finalists between the 1st of November 2022 to the 18th of November 2022.

#### IV. Uploading of Videos on Innovative Pedagogy by the Teacher on Vidya Amrit Portal (15 Sept. to 31 Oct, 2022)

- 1. School Teachers may be requested to upload their videos on innovative pedagogy on the Vidya Amrit Portal.
- 2. Rating (in the form of stars) will be provided by the viewers on these videos.
- 3. Guidelines on the Video and its uploading will be provided by the CIET by 25<sup>th</sup> August 2022. Technical know-how of uploading of videos also needs to be observed by the CIET.




#### Overview

The objectives laid out in the National Education Policy 2020 necessitate fostering new behavior and practices in all stakeholders of the school education system. This can be achieved by developing the habit of continuous and innovative improvements. Acknowledging the potential of this approach, the Vidya Amrit Initiative was launched on July 29, 2022.

The Vidya Amrit Initiative aims to **encourage**, **recognise** and **nurture** innovations across the 1.5 million schools in our education system, by breaking down big ideas into a series of micro-improvements. Vidya Amrit Mahotsav, under Vidya Amrit Initiative, will promote and recognise micro-improvements for innovative pedagogy implemented by the teachers and school leaders across India. This starter pack serves as a guiding document for states to conduct the Vidya Amrit Mahotsav in their states. It introduces the concept of microimprovements and implementation details for Vidya Amrit Mahotsav.

#### **Micro-Improvement Approach**



Aligned with the 'Learn–Do–Practice' of NDEAR, the micro-improvement approach breaks down desirable processes for school improvement into small, tangible and achievable objectives. Under this approach, these objectives are further broken down into logical, actionable steps. These objectives and action steps together form a micro-improvement. Each micro-improvement is a step towards creating a significant and sustainable change. Most importantly, it helps answer a critical question for all the stakeholders: *What can I do to make things 1% better today than they were yesterday?* 

"In order to make meaningful changes to the way we work, don't start with a mammoth challenge. Start small"

#### Vidya Amrit Mahotsav Implementation Plan

Vidya Amrit Mahotsav will recognize teachers and school leaders for their innovative pedagogical practices. Using the micro-improvement approach enabled by DIKSHA, states will be able to roll out their Vidya Amrit Mahotsav programs. Teachers and school leaders can submit their innovative practices as projects on DIKSHA. These projects will be evaluated and the best innovations will be celebrated and shared with everyone.

Suggested Communication Plan (September, Week 2 – December, Week 3)

To ensure greater participation among school leaders, teachers and their school teams as well as to recognize and appreciate their efforts, the state can conduct various activities on different media. Some suggested ideas are mentioned below:

#### State Launch

- 1. Invite a <u>brand ambassador /</u> <u>campaign leader</u>
- 2. Create and share a <u>media plan</u> with the ambassador
- Conduct a <u>launch event</u> with state dignitaries, education experts, and senior teachers and school leaders
- Invite ecosystem actors (consultants, NGOs etc) to work towards the Mahotsav with the state.

#### Whatsapp Communication


- 1. Communicate <u>daily metrics</u> (number of projects started and completed) to district officials, school leaders and teachers
- 2. Share <u>inspirational messages</u> with district officials, school leaders and teachers
- 3. Share <u>videos from teachers and school</u> <u>leaders</u>, as well as <u>best practices videos</u> from the other states curated from the NCERT Vidya Amrit Mahotsav channel
- 4. Share <u>block level exhibition images</u> and invite reactions from school leaders and teachers
- 5. Share <u>links to the DIKSHA video collection</u> of the top 15 projects

#### Social Media Campaign

- Motivate <u>teachers and school leaders to upload their videos</u> on social media, using the suggested hashtags: #SchoolSawareinHum, #MicroImprovements, #VidyaAmrit, #MyNeighbourhoodSchools, #VidyaAmritMahotsav, #TeachersareLeaders, #IforInnovation
- 2. Reshare <u>posts from teachers and school leaders</u> on social media platforms with the suggested hashtags.
- 3. Post <u>updates about teachers' and school leaders' innovations</u> on social media platforms with suggested hashtags.
- 4. Upload best innovation projects on the platforms.
- 5. Upload state level awards ceremony or festivities on the platforms.
- 6. Share views by education experts, senior teachers, teacher mentors, retired school leaders and department officials on culture of innovation, innovative pedagogy, concept of improvement etc.



#### DIKSHA Preparedness (September, Week 2 - September, Week 3)

#### State Readiness

State prepares for the Vidya Amrit Mahotsav by updating school details and sub-roles on DIKSHA, and getting DIKSHA platform rights. States can access the data of submitted innovations from Program Dashboards with Program Manager rights. More details on these actions can be found in Annexures II and III.

#### Update School List on DIKSHA

- 01 Check if the data of schools with correct UDISE codes, Districts and Block details are updated. If not, use template in Annexure II named 'State Preparedness' to update data
- 02 State SPOC shares updated template with data of all schools via mail to projectsupport@teamdiksha.org to get school's data updated on DIKSHA
- 03 DIKSHA Team will update the school details on the platform in 15 working days

#### Update Sub-role on DIKSHA\*

- 01 Sub-roles specify the different kinds of users who are present on a state tenant
- 02 To specify the sub-roles for your state, use the template in Annexure II named 'State Preparedness'






#### Accessing projects: Teachers logging in for the first time




Accessing projects: School Leaders logging in for the first time




#### Accessing projects: Teachers who have logged in before



Block-level recognition structure	Each block (education officer) nominates 1–2 teachers and school leaders with the best innovations. To arrive at the nominations, they may conduct micro-improvement exhibitions at the block level. Teachers and school leaders who exhibit their innovations may be evaluated partly by other teachers and school leaders (as part of the exhibition) and partly by the block level jury.		
District-level recognition structure	District teams share the names of the nominated teachers and school leaders and their .csv project reports are shared with the district jury. Each district jury nominates 2–3 teachers and school leaders with the best innovations. These nominations are derived from the jury's evaluation using the .csv reports.		

State-level recognition structure	The state jury selects the top 15 teachers and school leaders. (It is suggested that the 2–3 nominated teachers and school leaders from each district are invited for an exposure visit at the state level, where within the entire celebration schedule, another Micro-Innovations exhibition is set up.)
DIKSHA video collection	The state curates the videos from these 15 teachers and school leaders as a DIKSHA video collection. Based on the consumption data, the state may evaluate these videos along three criteria: number of times a video is played, average play time and average rating. The top 3 micro-improvement projects are selected and shared with NCERT.
National evaluation	NCERT evaluates the submissions received from the states.

Once approved, the learning resource gets automatically published on DIKSHA. Note: Improvement Projects cannot be reviewed on the DIKSHA workspace. They have to be reviewed manually by an individual in the State Education Department. Once reviewed, the program designer can send the request for upload.
Program Designer	This role will help the state to raise a request for uploading projects under a specific program & track status of completion of projects in the state. The role will have <b>access</b> to status reports only. <b>Note:</b> Program Designer should also have the creator rights on the platform.
Program Manager	This role will help the state to manage the implementation of the project by providing overall data of users with respect to project consumption & completion. The role will have <b>access</b> to both the reports (status & tasks) on the program dashboard of DIKSHA.
Report Viewer	This role will help you to view all charts published for their state on DIKSHA portal. These are accessed via the 'Admin Dashboards' page on DIKSHA portal. The data available in the admin dashboard is aggregated data.
